CLUB RULES DECLARATION FORM

By signing this form, I hereby agree to abide by the rules, regulations, and bylaws of the Club.

Membership Account & Access

(a) Members must present their physical membership card at all points of entry into the Club.

(b) Members must present their membership card at the point of ordering or transaction at all outlets, or when asked by Club employees.

(c) Guests must be signed in and accompanied by a Member at all times.

(d) Lost or stolen cards must be reported to the Membership Office immediately.

(e) Members must not divulge their membership number to anyone. It must be kept private.

Carpark Etiquette

(a) Members and their drivers must adhere to the 20km/h speed limit in the Carpark.

(b) Two Five-minute Parking Bays are located at Carpark level one. They are for quick dropoffs and pick-ups only. Chauffeured vehicles are not allowed in these lots.

(c) Two EV charging lots are located at Carpark level one. They are strictly for charging of EV vehicles only.

Driver Pass
