Associate Membership Lifetime, non-transferable membership open to any person who is not eligible for Ordinary Membership.	This category is currently closed.
Transferable Membership	Transfer Fee (w/GST)
Transferable Memberships are available on the open market. Such transaction is between the seller and the buyer. A transfer fee of 25% of The Club's listed rate, currently at \$\$32,700.00, is payable to The American Club at the time of submission of the transfer form.	\$39,240.00 Transfer Fee: \$39,240.00 Operations Surcharge: \$5,585.00* *Payable by new member.

## **CORPORATE MEMBERSHIP**

The General Committee may at its discretion elect U.S. or Canadian corporations or partnerships incorporated, registered, or represented in Singapore as Corporate Members. Upon cessation of Corporate Membership, all Corporate Nominees, shall at the same time, cease to enjoy any of the facilities of The Club.

Class A: \$109,000.00 for three nominees Class B: \$81,750.00 for two nominees Class C: \$54,500.00 for one nominee

- Corporate Membership is not transferable and all fees paid for such Membership are non-refundable.
- Corporate Members are liable for the payment of all subscriptions, registration fees, and monies due on the accounts of their Nominees with The Club.

Each nominee application/re-nomination must be accompanied by a company letter or email, along with payment for \$8,310.00 (Transfer Fee of \$2,725.00 and Operation Surcharge of \$5,585.00, inclusive of GST). If a corporate place is left vacant, prevailing Single Dues (reference Monthly Dues) will be charged to the corporate account.

#### **OPERATIONS SURCHARGE**

An Operations Surcharge is payable for every new Membership application.

# **REFUND POLICY**

- All fees paid are non-refundable with the exception below.
- Any Ordinary Member who resigns from The Club, by written notice within twelve (12) months, from date of issuance
  of temporary Membership card may apply for one half (1/2) of the one-time entrance fee which he or she has paid
  per 15(b) of The Constitution. This policy does not apply to payment plan applications.
- Grant of any such refund shall be at the discretion of the General Committee.

- All fees are inclusive of prevailing Goods and Services Tax (GST).
- The Club reserves the right to amend the fees and update any information without prior notice.
- The Club reserves the right to check references and verify information submitted.
- All Applications undergo an evaluation process and is subject to acceptance by the General Committee.
- The Club has the right to refuse applications without further comment.

☐ <b>Photograph</b> – Colored passport-sized photograph of all applicants except children below 12 years old.
☐ <b>GIRO Form</b> – Original, fully accomplished GIRO form.
□ PDPA – Fully accomplished Personal Data Protection Acknowledgement Form, with initials on every page and full signature at the last page.
□ Endorsement Forms – Two Endorsement Forms are required. Endorsement Forms may come from the following entities: - A full-fledged Member of The American Club Singapore in good standing - Previous Club Endorsement Letter – A maximum of one
☐ <b>Full Payment of Joining Fee</b> - Full amount of the Joining Fee based on the membership category. A non-refundable Processing Fee of \$1,000 will be offset against the Joining Fee if the application is unsuccessful.

#### **CLUB RULES DECLARATION FORM**

By signing this form, I hereby agree to abide by the rules, regulations, and bylaws of the Club.

# **Membership Account & Access**

- (a) Members must present their physical membership card at all points of entry into the Club.
- (b) Members must present their membership card at the point of ordering or transaction at all outlets, or when asked by Club employees.
- (c) Guests must be signed in and accompanied by a Member at all times.
- (d) Lost or stolen cards must be reported to the Membership Office immediately.
- (e) Members must not divulge their membership number to anyone. It must be kept private.

## **Carpark Etiquette**

- (a) Members must be always present in the Club while parked in the Carpark.
- (b) Members and their drivers must adhere to the 20km/h speed limit in the Carpark.
- (c) Two Five-minute Parking Bays are located at Carpark level one. They are for quick drop-offs and pick-ups only. Chauffeured vehicles are not allowed in these lots.
- (d) Two EV charging lots are located at Carpark level one. They are strictly for charging of EV vehicles only.

#### **Driver Pass**

- (a) Access is limited to the Carpark only.
- (b) Driver pass must be presented upon entry into the Carpark.
- (c) Only registered vehicles are allowed into the Carpark.

#### **Helper Pass**

- (a) Helpers can only accompany Members' children to the Club before and after scheduled classes. They cannot accompany Members' children for recreational activities in the Club.
- (b) Helpers holding the green pass may order food for Members' children at Grillhouse and Tradewinds only from Monday to Friday, 3:00 p.m. 7:00 p.m., before and after their scheduled classes. Members' children must be present in order for the Helper to place food orders.
- (c) Helpers holding the orange pass are not allowed to order food for Members' children. They are only allowed into the Club to drop-off and pick-up Members' children from scheduled classes only.

#### **Electronic Devices**

Usage of hand phones and other electronic communications devices is restricted to certain common areas of the Club. Please refer to the signage at each outlet or area and ask Club staff if unclear. In areas where usage is permitted, members are encouraged to use their communication devices in a respectful manner, and to put them on silent mode while at the Club.

#### **Food & Drinks**

- (a) Members and Guests are not allowed to bring outside food and drinks for consumption in the Club unless they are required for medical purposes or intended for children below two years old.
- (b) Members' children and Guests below 18 years old are not permitted in Union Bar nor are they allowed to consume alcohol on Club premises.
- (c) Members' children and Guests aged 18 years old and above must present a valid membership card, original passport, or Singapore government-issued ID to Club employees prior to ordering alcoholic beverages.

#### **Dress Code**

- (a) Members and Guests must adhere to The 2nd Floor's dress code. Failure to do so may result in denied entry.
- (b) Bathing suits should only be worn at the Pool. Wet attire is not allowed elsewhere in the Club, and shoes must be worn at all times.

#### **Children's Safety**

- (a) Children below 12 years old must be accompanied by an adult Member at all times except when signed into The Quad and Quad Poolside.
- (b) Members are responsible for the behavior of their children. Please ensure that they do not run or misbehave in the Club.

#### Music, Photography and Recording

- (a) Music and audio may not be played out loud in the Club. Members are welcome to use headphones to listen to music or watch videos.
- (b) Photography, videography and audio recordings taken with the intent of commercial use is strictly prohibited.
